International Applicants for Scholarship Stays in Slovakia

What is offered?

- scholarships covering living costs for
 - students studying at universities outside Slovakia in order to undertake a study stay (1 – 3 semesters) at a university in Slovakia during their higher educational studies, or during higher vocational studies, if the applicant has completed a level 3 years of higher education at the beginning of his/her study stay in Slovakia)
 - PhD students studying at universities/research organisations outside Slovakia in order to undertake a research stay (1 – 10 months) at a university or research organisation in Slovakia during their doctoral studies
 - university teachers, researchers or artists working at universities/research organisations outside Slovakia in order to undertake a teaching/research stay (1 – 10 months) at a university or in other scientific research organisation in Slovakia
- travel allowance to cover travel costs related to a study/research stay in Slovakia in case of students and P-D students

Citizens of which countries are eligible applicants?

Citizens of any country in the world can apply for a scholarship in the framework of the National Scholarship Programme of the Slovak Republic, except the citizens of the Slovak Republic.

What is the amount of the monthly scholarship?

- university student 400 €
- PhD student 334 €

- university teachers, researchers or artists working at universities/research organisations outside Slovakia in order to undertake a teaching/research stay (1 – 10 months) at a university or in other scientific research organisation in Slovakia
- university teachers, researchers or artists working at universities/research organisations outside Slovakia in order to undertake a teaching/research stay (1 – 10 months) at a university or in other scientific research organisation in Slovakia



What is the amount of the monthly scholarship?

- students studying at universities outside Slovakia in order to undertake a study stay (1 – 3 semesters) at a university in Slovakia during their higher educational studies, or during higher vocational studies, if the applicant has completed a level 3 years of higher education at the beginning of his/her study stay in Slovakia)
- PhD students studying at universities/research organisations outside Slovakia in order to undertake a research stay (1 – 10 months) at a university or research organisation in Slovakia during their doctoral studies
- university teachers, researchers or artists working at universities/research organisations outside Slovakia in order to undertake a teaching/research stay (1 – 10 months) at a university or in other scientific research organisation in Slovakia

How to apply?

Applicants must apply online at www.stipendia.sk. The application system is operated by the Ministry of Education, Youth and Sports of the Slovak Republic. Application must be submitted in the online system at the application deadline. It is also necessary to deliver original of the admission/invitation letter to SAIA, n.o. in Bratislava. Detailed information on submitting applications and required documents is available at the website of the Programme.

What are the deadlines for submitting applications?

- 30 April till 16:00 CEST – scholarship stays during the next academic year
- 31 October till 16:00 CEST – scholarship stays during the summer semester of the current academic year

Applicants from Slovakia for Scholarship Stays outside Slovakia

What is offered?

- scholarships covering living costs for
 - students studying at universities in Slovakia in order to undertake a study stay (1 – 2 semesters or 1 – 3 trimesters) outside Slovakia during their master's studies, or a research stay (3 – 6 months) closely related to the completion of doctoral studies
 - PhD students studying at universities (including external education institutions, e.g. Slovak Academy of Sciences) in Slovakia in order to undertake a study and/or research stay (1 – 10 months) in Slovakia during their doctoral studies
 - doctoral researchers working at universities and research institutions in Slovakia in order to undertake a research stay (3 – 6 months) in Slovakia

More entry conditions and more information about the Programme is available at the website of the Programme.

Which country can you choose for your scholarship stay?

The Program is available in 100 countries. Scholarship stays can be carried out in any country in the world.

What is the amount of the monthly scholarship?

The amount of the scholarship is set for each country separately. The scholarship amount covers average living costs in the respective country during the stay. When setting the amount of the scholarship, only living expenses taken into consideration are not covered by costs, e.g. tuition fees. Amounts of monthly scholarships to the countries where scholarship stays have already been carried out is available at www.stipendia.sk.

What is the amount of a travel grant?

- The amount of the travel grant depends on the air distance between the applicant's stay in Slovakia and the place of his/her stay abroad
 - up to 3500 km – 0 €
 - from 3500 to 20000 km – 250 €
 - from 20000 to 70000 km – 500 €
 - more than 70000 km – 1000 €

How to apply?

Applications are submitted online at www.stipendia.sk. Online application system is operated at least 6 weeks prior to the application deadline. Applicants must be authorised in the online application system till the application deadline. Detailed information on submitting applications and required documents is available at the website of the Programme.

What are the deadlines for submitting applications?

- 30 April till 16:00 CEST – scholarship stays during the next academic year
- 31 October till 16:00 CEST – scholarship stays during the summer semester of the current academic year

we would like to inform you that a **new call for applications within the National Scholarship Programme of the Slovak Republic is open** for study, research and teaching stays during the summer semester of the academic year 2020/2021.

Scholarship **application deadline is 31 October 2020 by 16:00 CET** (4:00 pm Central European Time). Scholarship stays can be planned during the summer semester of the academic year 2020/2021. Applications are submitted on-line at www.scholarships.sk (international applicants).

The National Scholarship Programme of the Slovak Republic supports mobility of international students, PhD students, university teachers, researchers and artists to stay at Slovak universities and Slovak research organisations. Students and PhD students can apply also for a travel allowance.

The National Scholarship Programme of the Slovak Republic is funded by the Ministry of Education, Science, Research and Sport of the Slovak Republic.

Next deadline for the submission of applications will be on 30 April 2021 for scholarship stays during the academic year 2021/2022.
